- Be a United States citizen or be lawfully present in the U.S.
- Live in the plan's service area Important: To join a Medicare Advantage Plan, you must also have both:

- <sup>1</sup> To be eligible for the Cash Back benefit, you must pay your own Part B premium, meaning you don't receive Medicaid or other forms of assistance to pay your Part B premium.
- <sup>2</sup> Mount Carmel MediGold Cash Back (HMO) is NOT eligible for the optional dental plans.
- <sup>4</sup> Your first EFT will occur on or around the 10th of the month following the plan's receipt of this form. Any and all past due premiums (if applicable) will also be withdrawn from your account at that time.
- <sup>5</sup> It may take two or more months for your monthly premium to begin coming out of your check. In most cases, the first deduction will include all premiums due from your enrollment effective date up to the point withholding begins.
